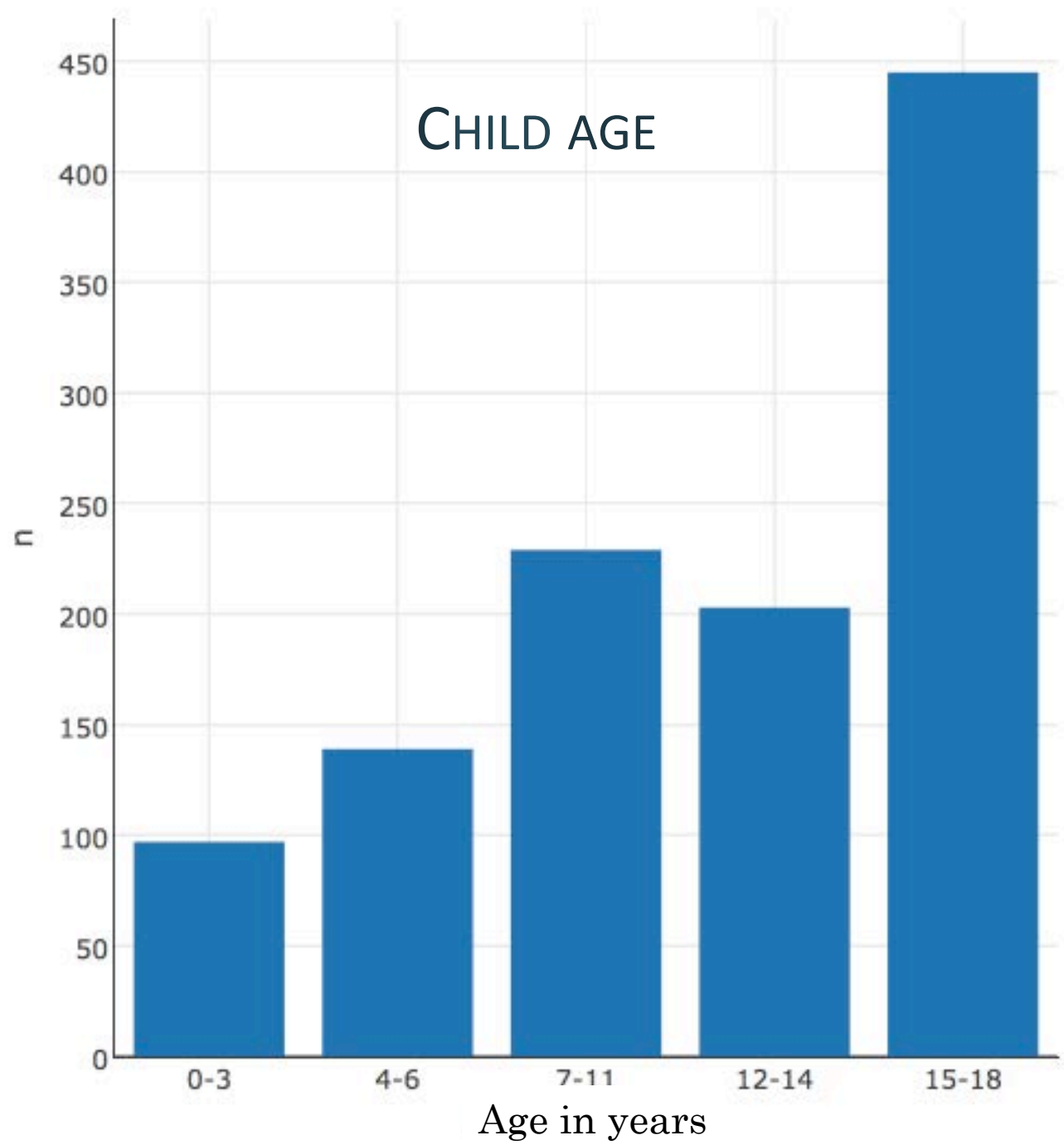
- Aim of the analysis: **Determining the needs:**
 - Is Data-safety/-security a current topic?
 - Is there a problem awareness?
 - Is demand formulated?
 - What kind of demand? What do the parents need?
- What else is of interest?
 - Analysing the needs in terms of child age and citizenship

ANALYSIS

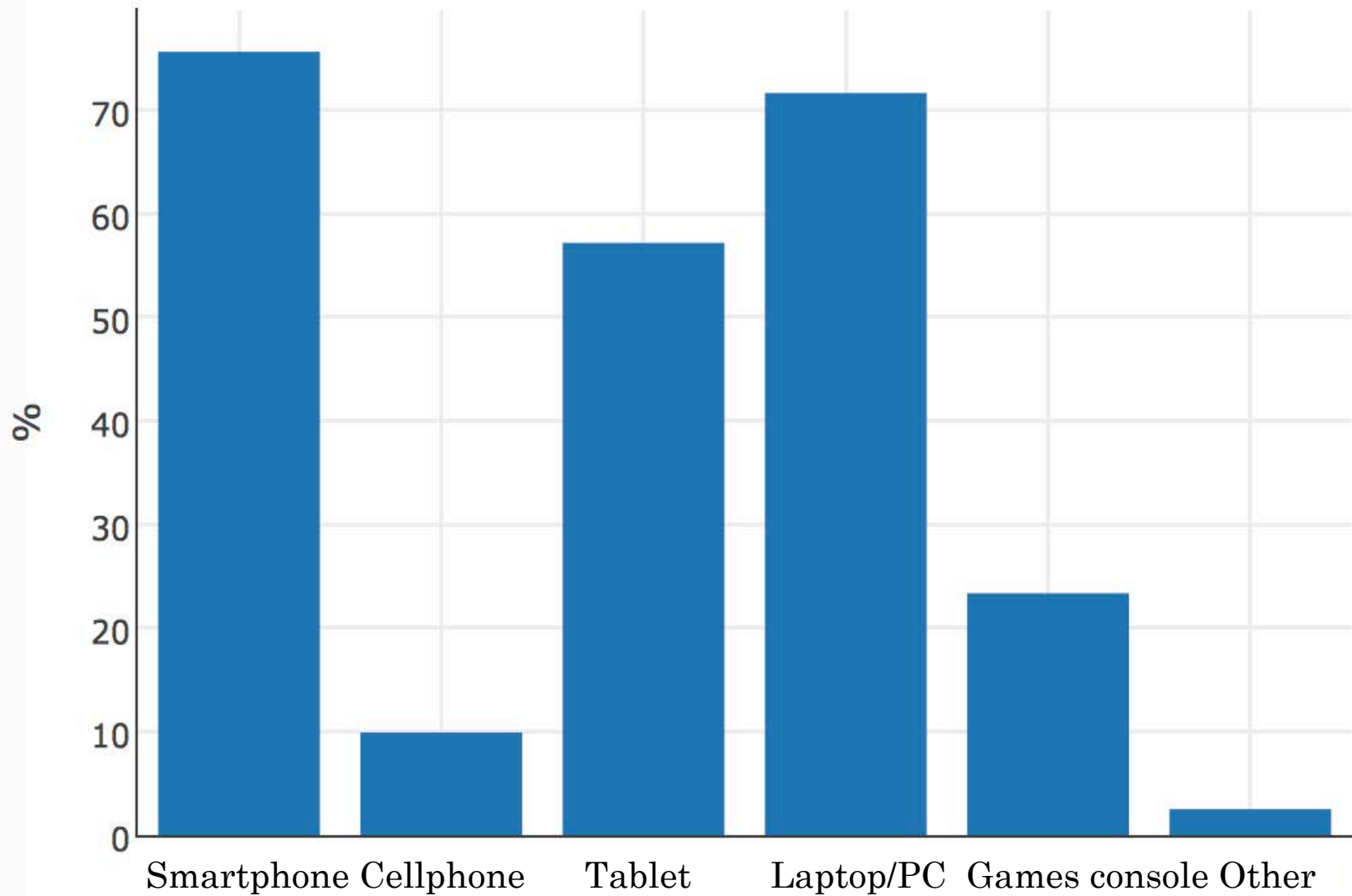
- The results are presented as frequencies mainly in inter-country comparison
- The reported numbers are given as percentage for better comparison
- Multiple answers were allowed for almost all questions

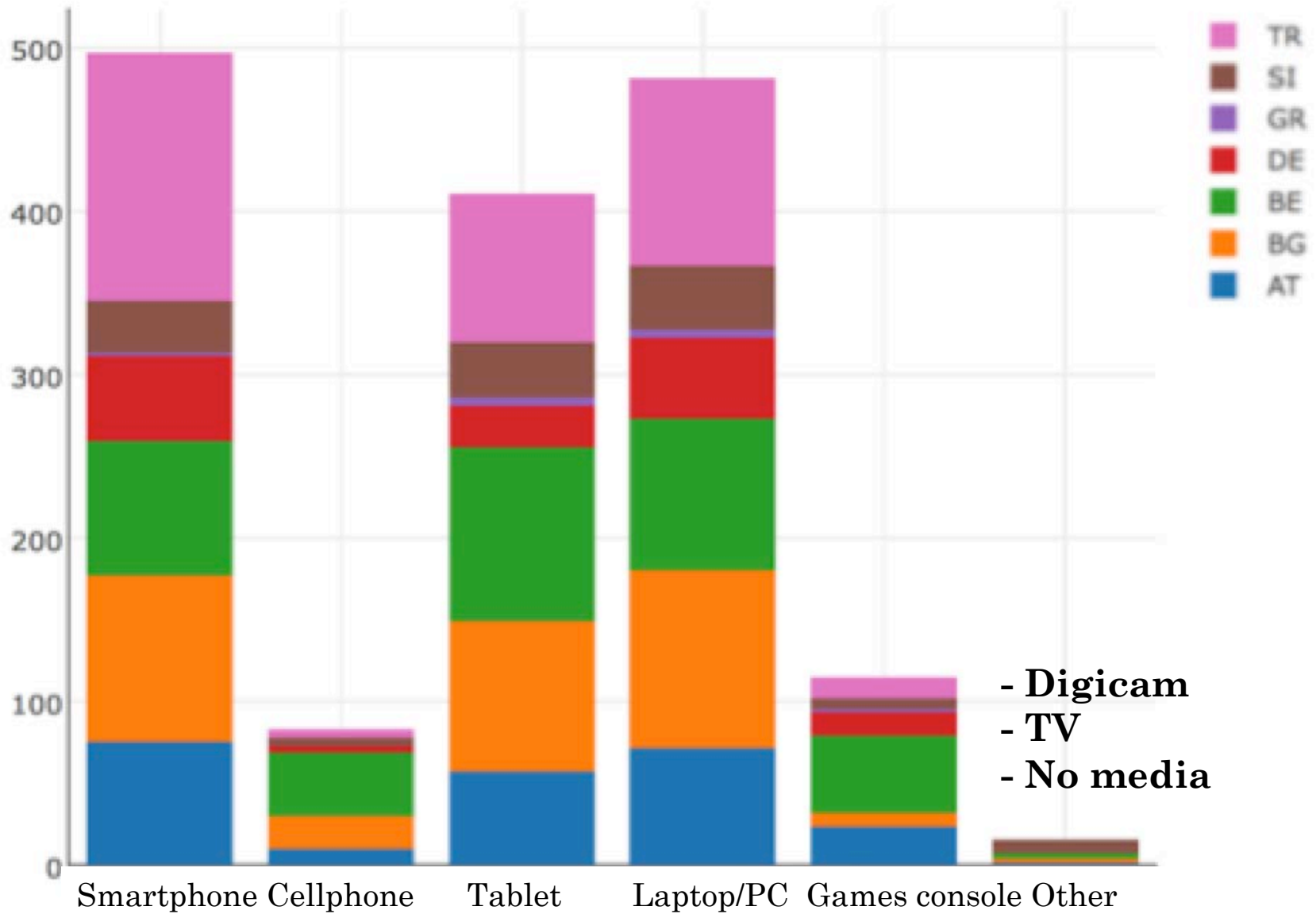
- 606 Parents (69%)

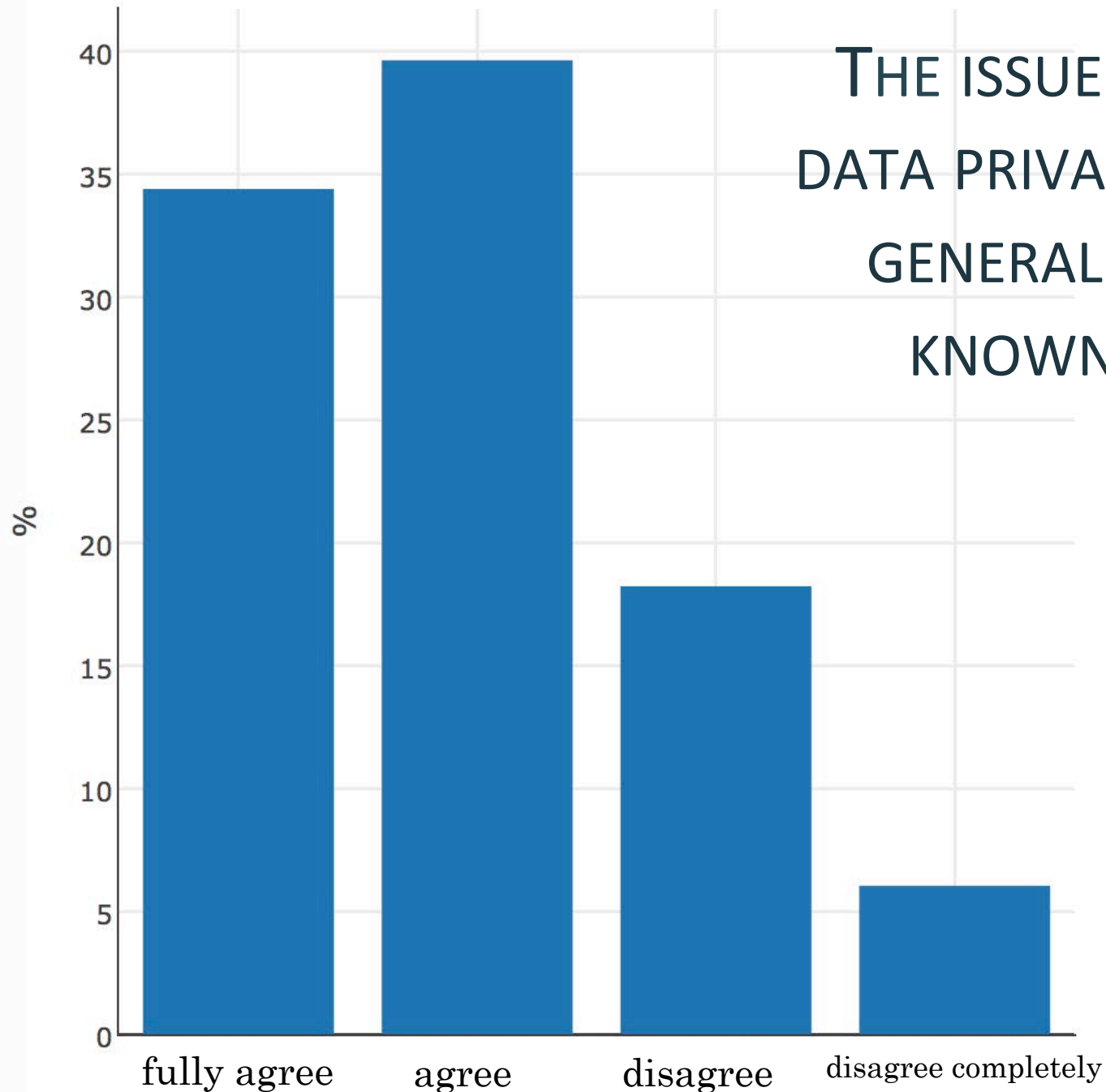

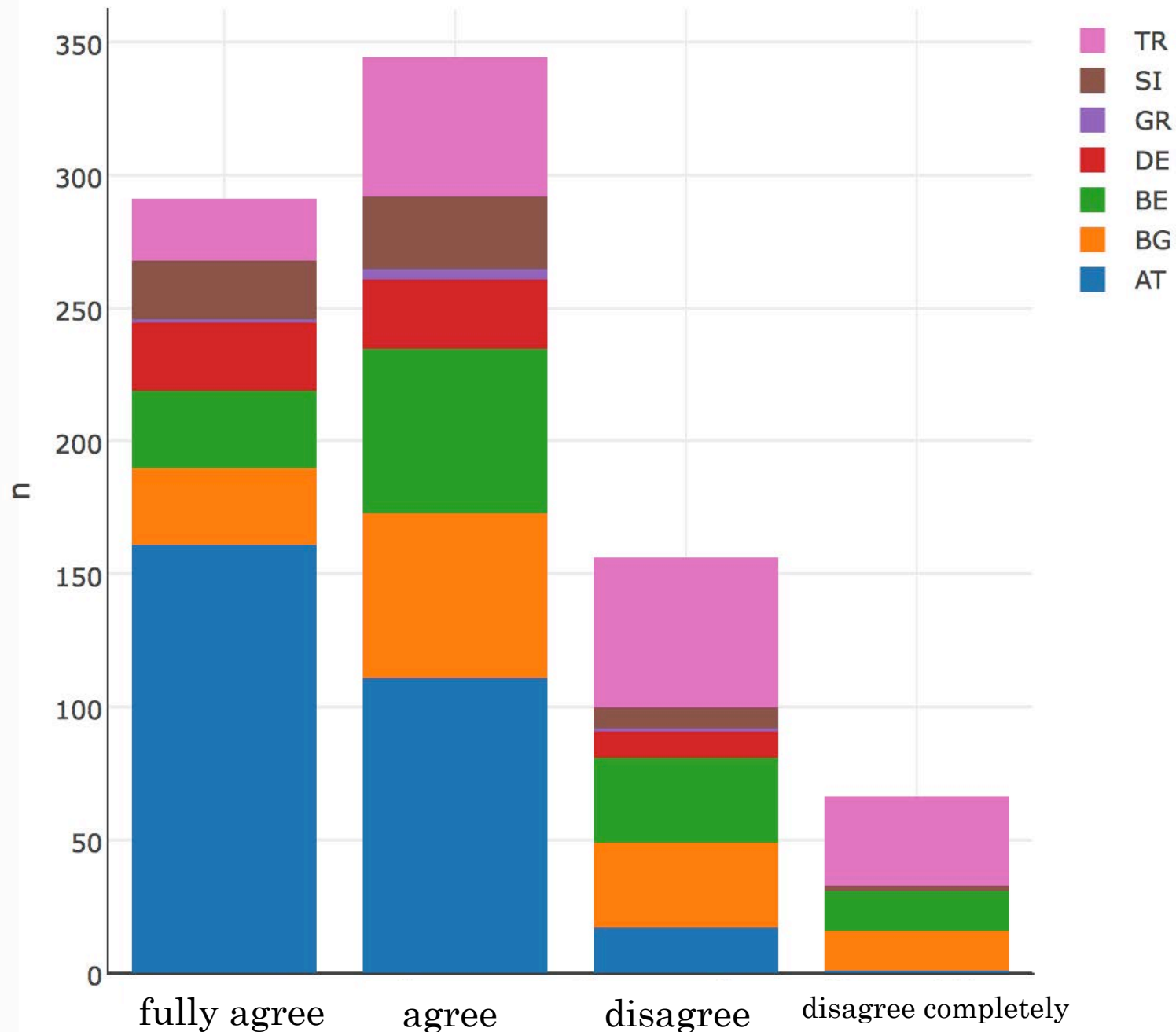

-32% CONCERNING APPS

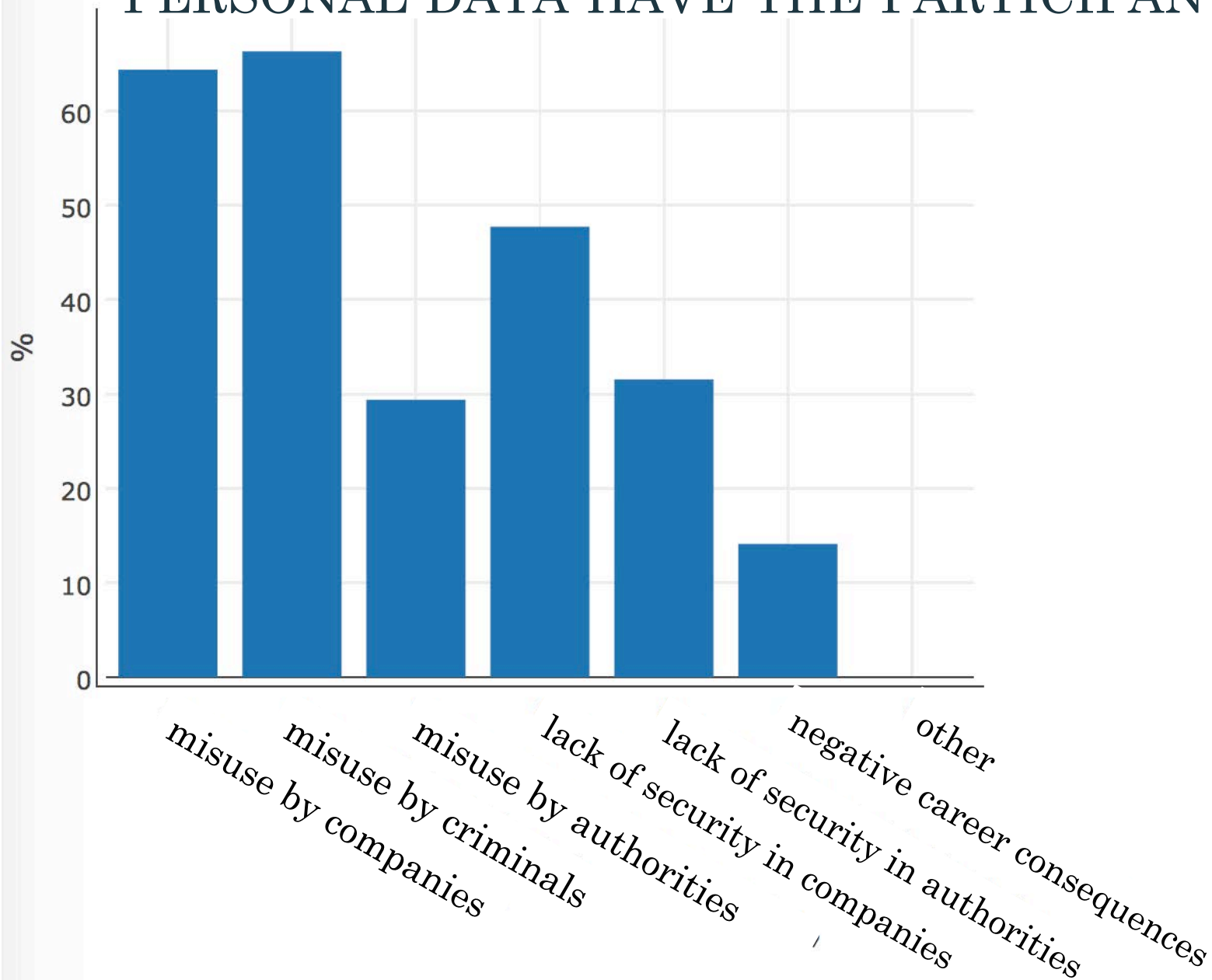
-38% CONCERNING CLOUD SERVICES

PROTECTING THEIR PERSONAL INFORMATION ONLINE.

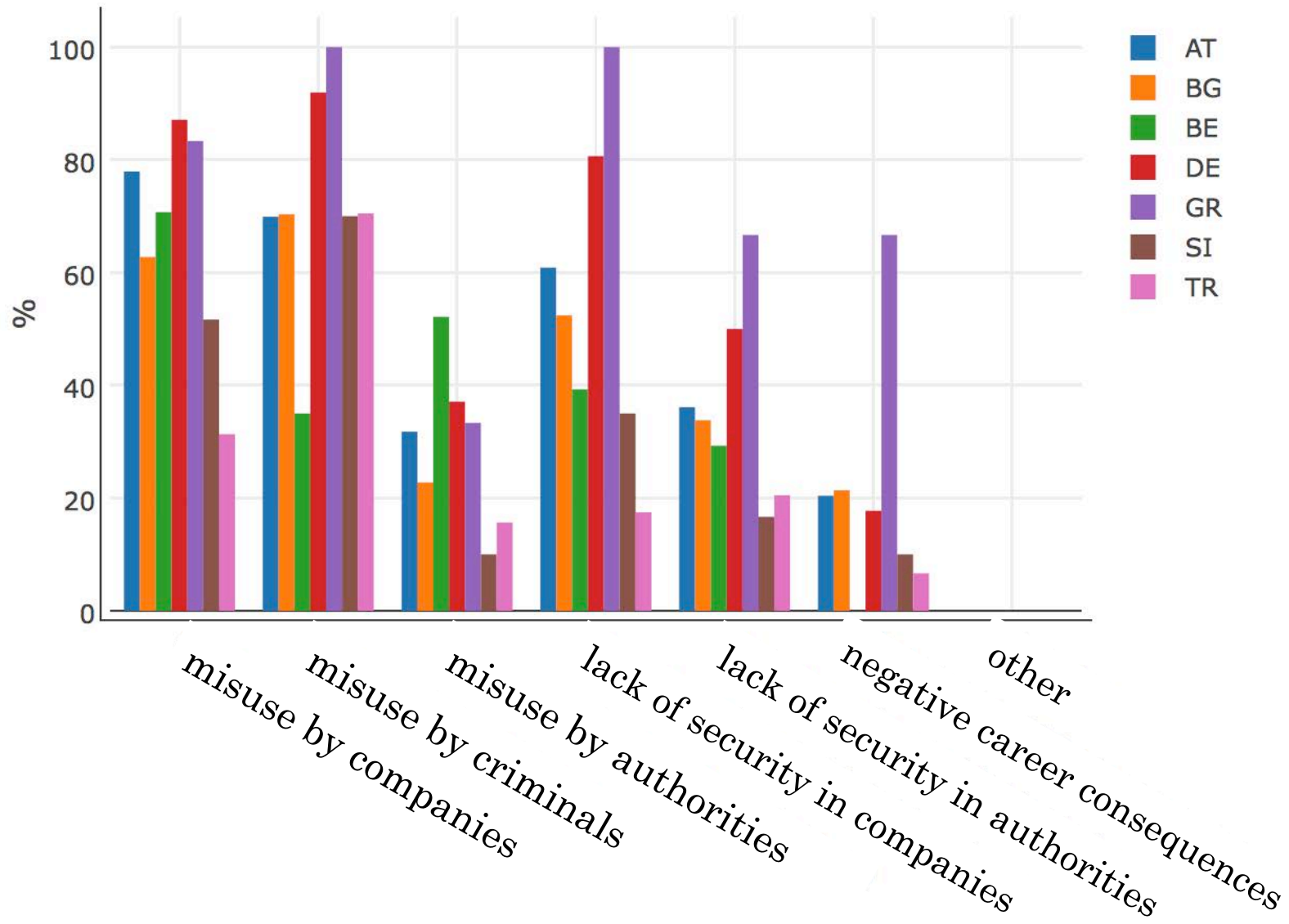
MOST CONCERNED ARE THE **GERMAN**

WHAT CONCERNS REGARDING THEIR PERSONAL DATA HAVE THE PARTICIPANTS?

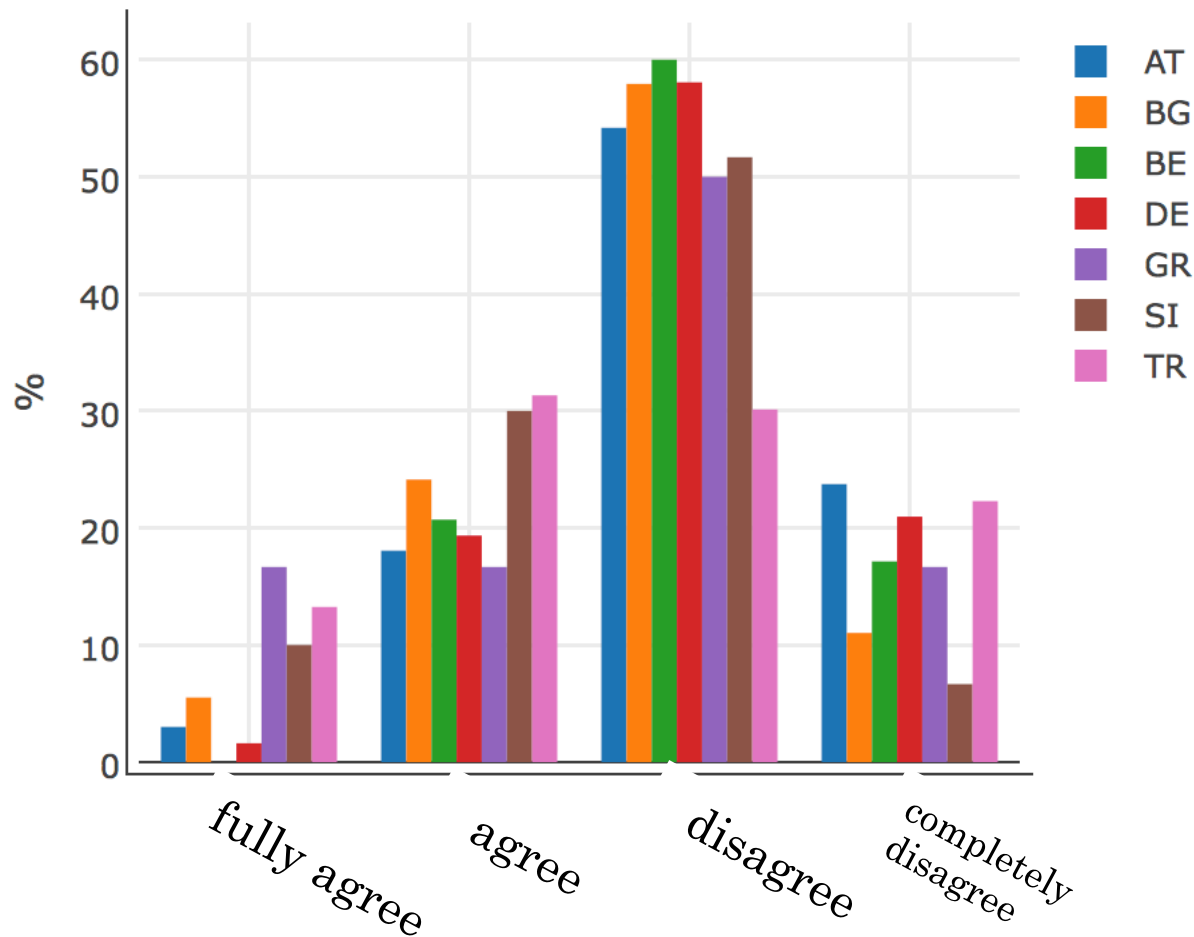


WHAT CONCERNS REGARDING THEIR PERSONAL DATA HAVE THE PARTICIPANTS?

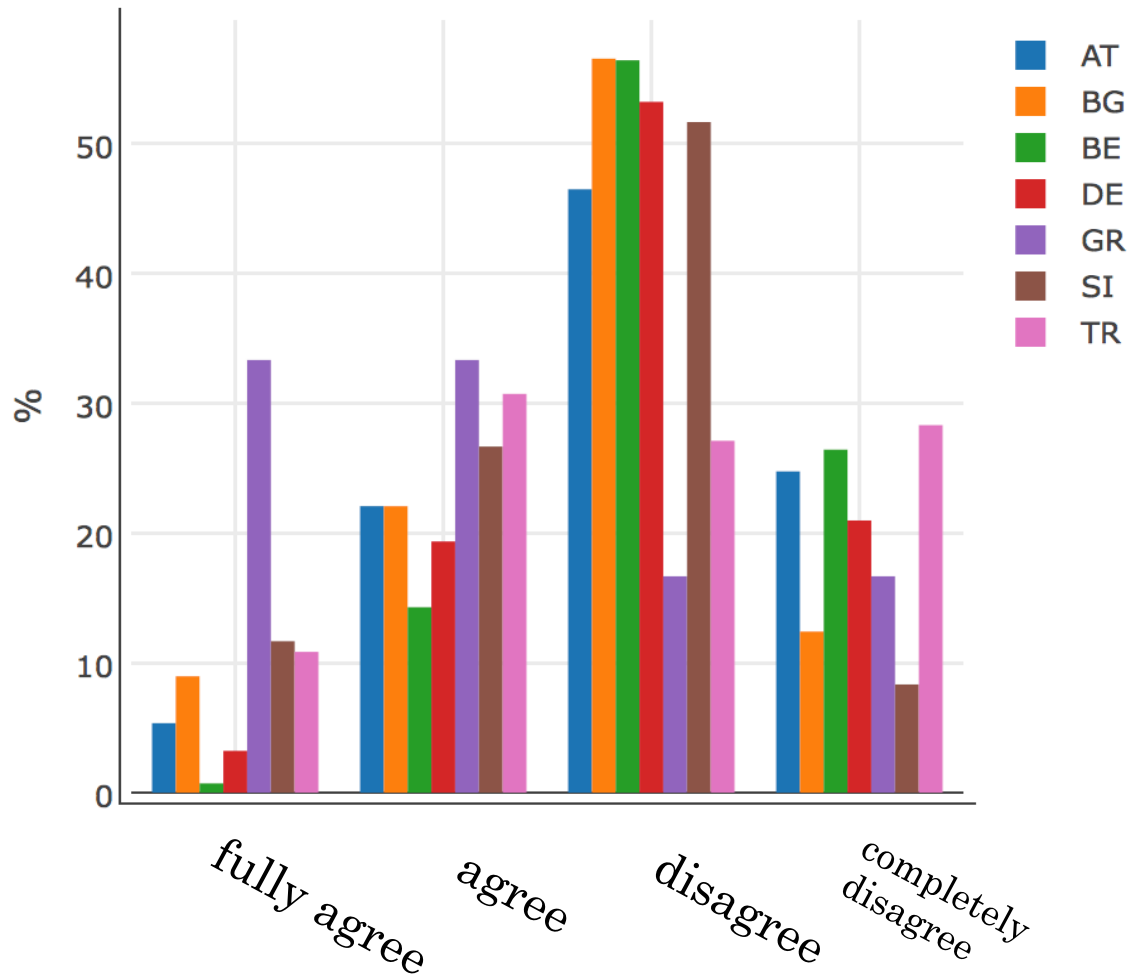

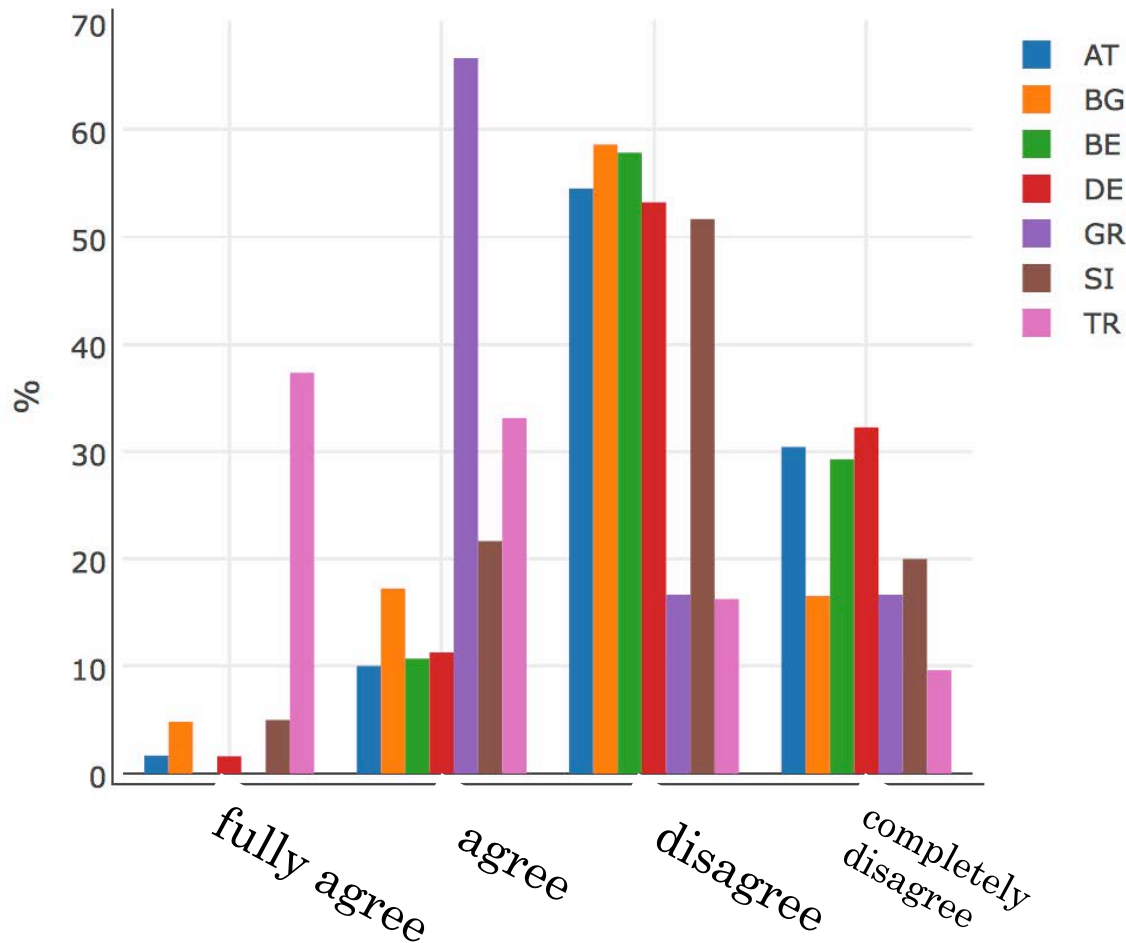

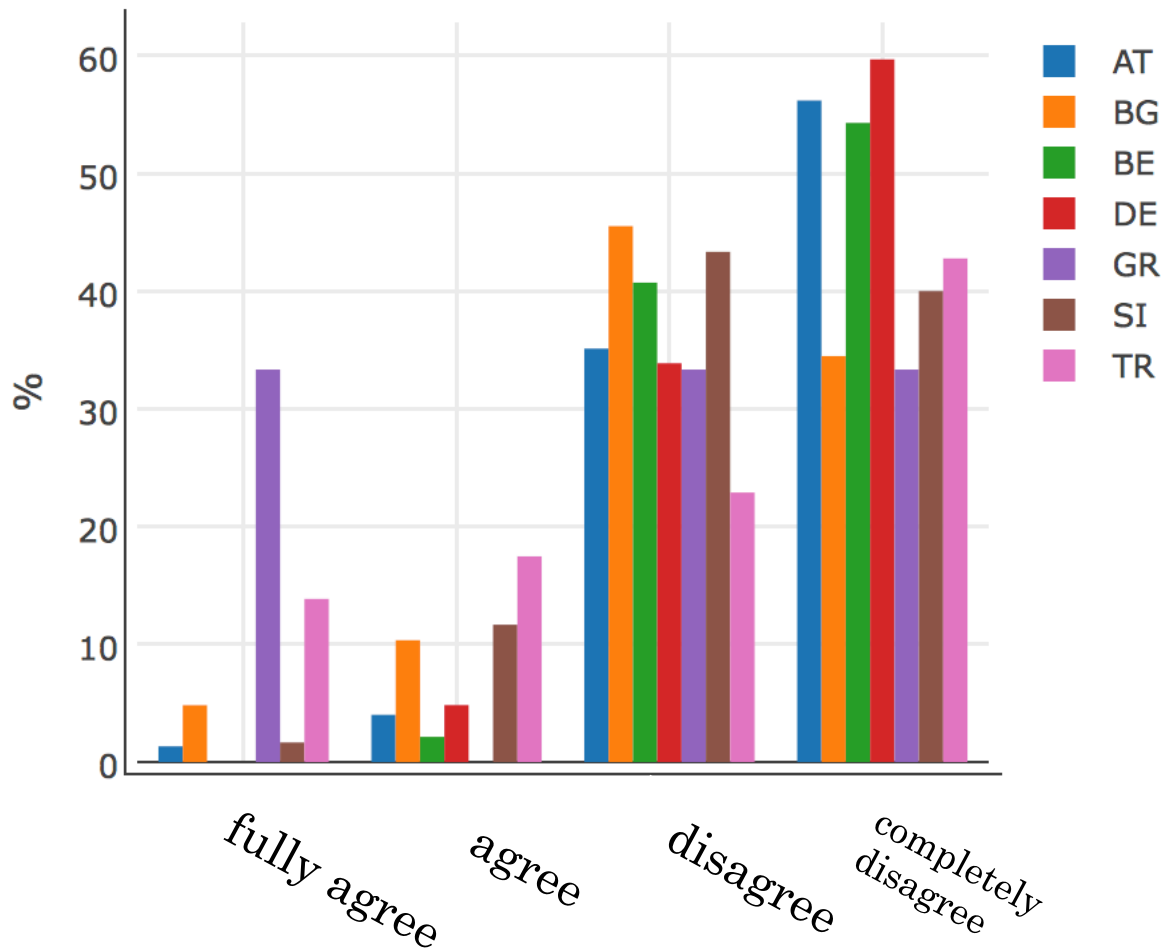

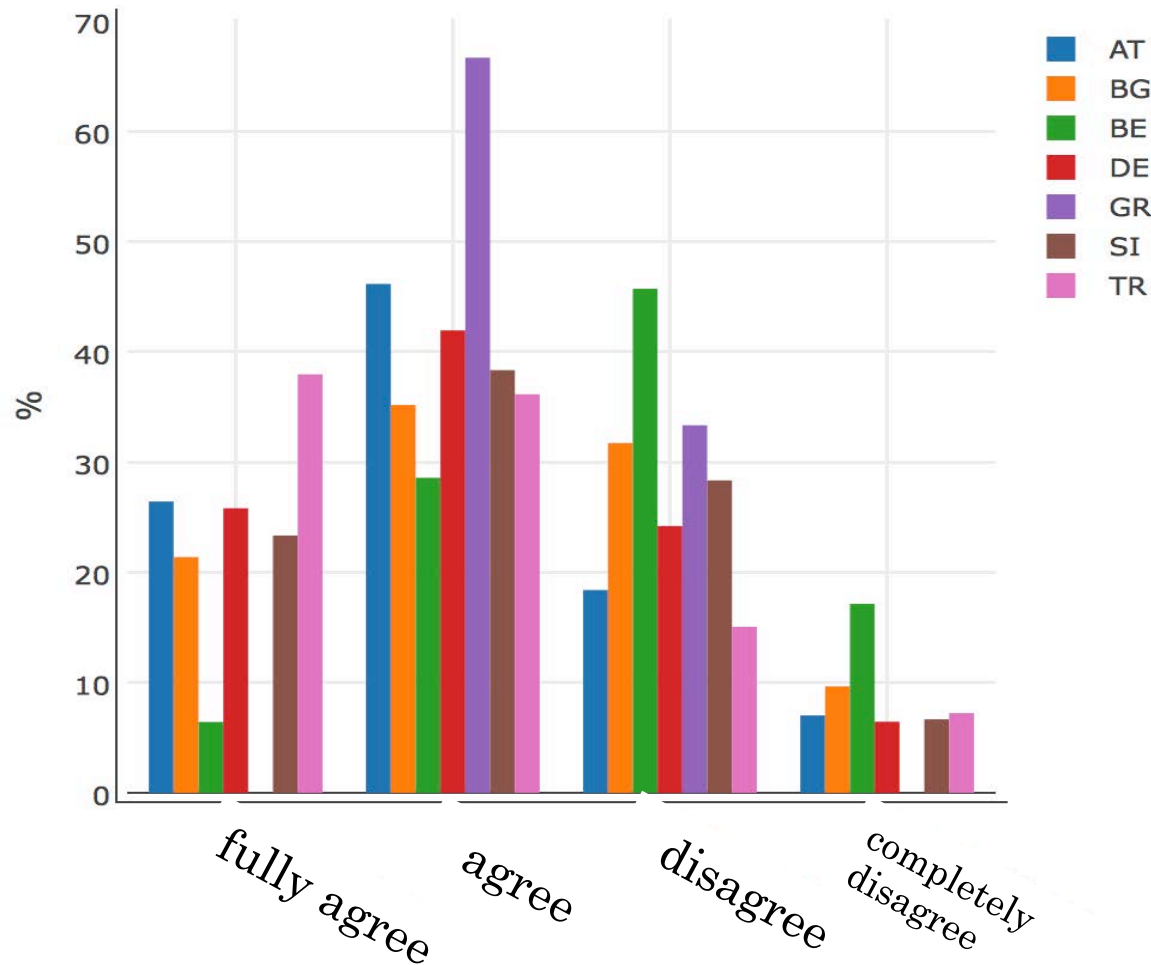

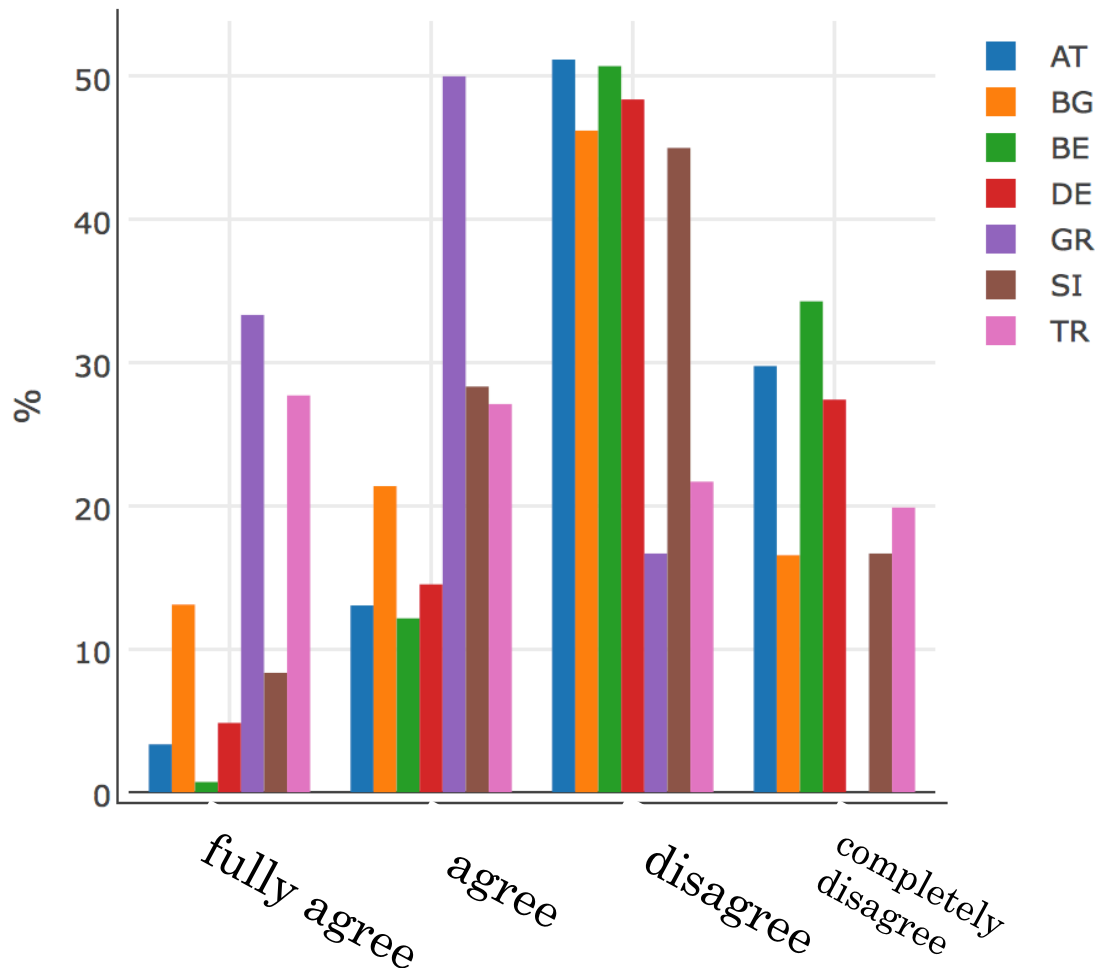

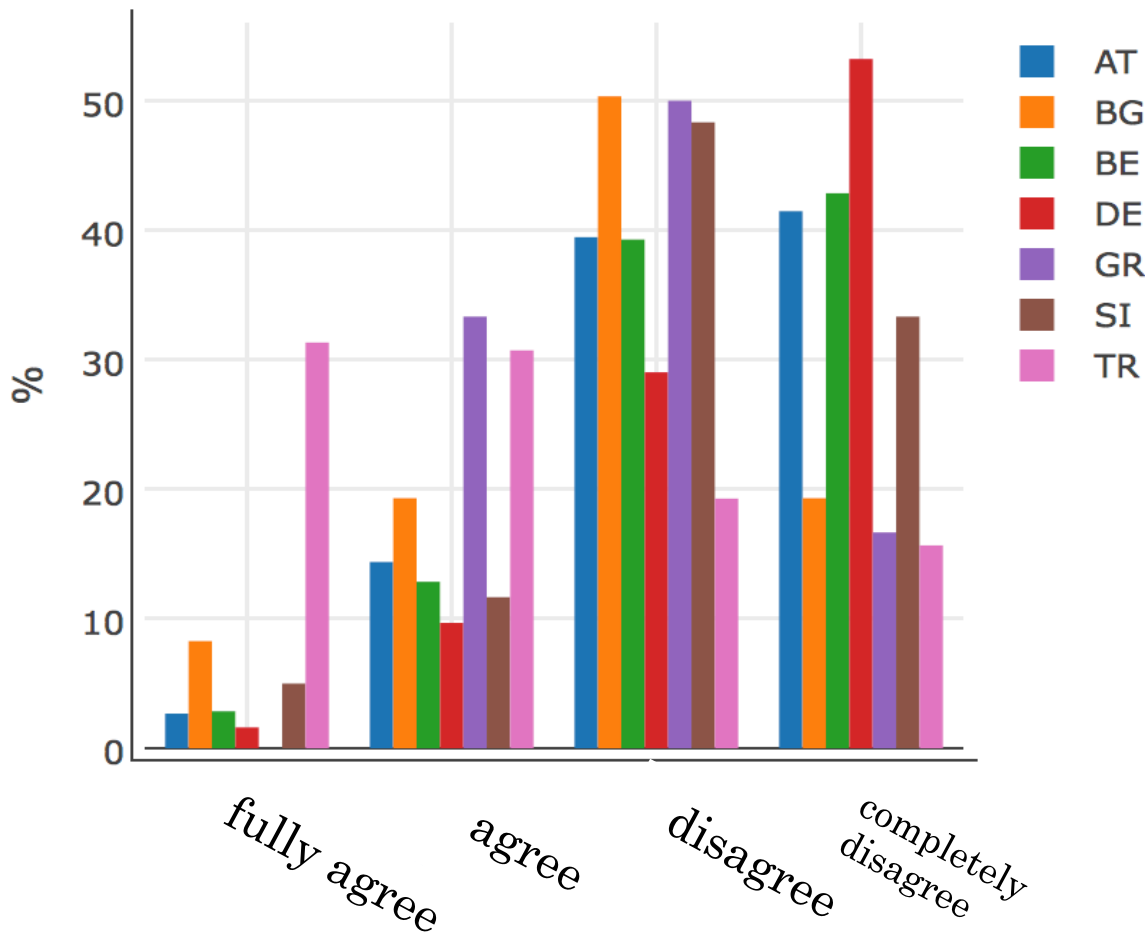

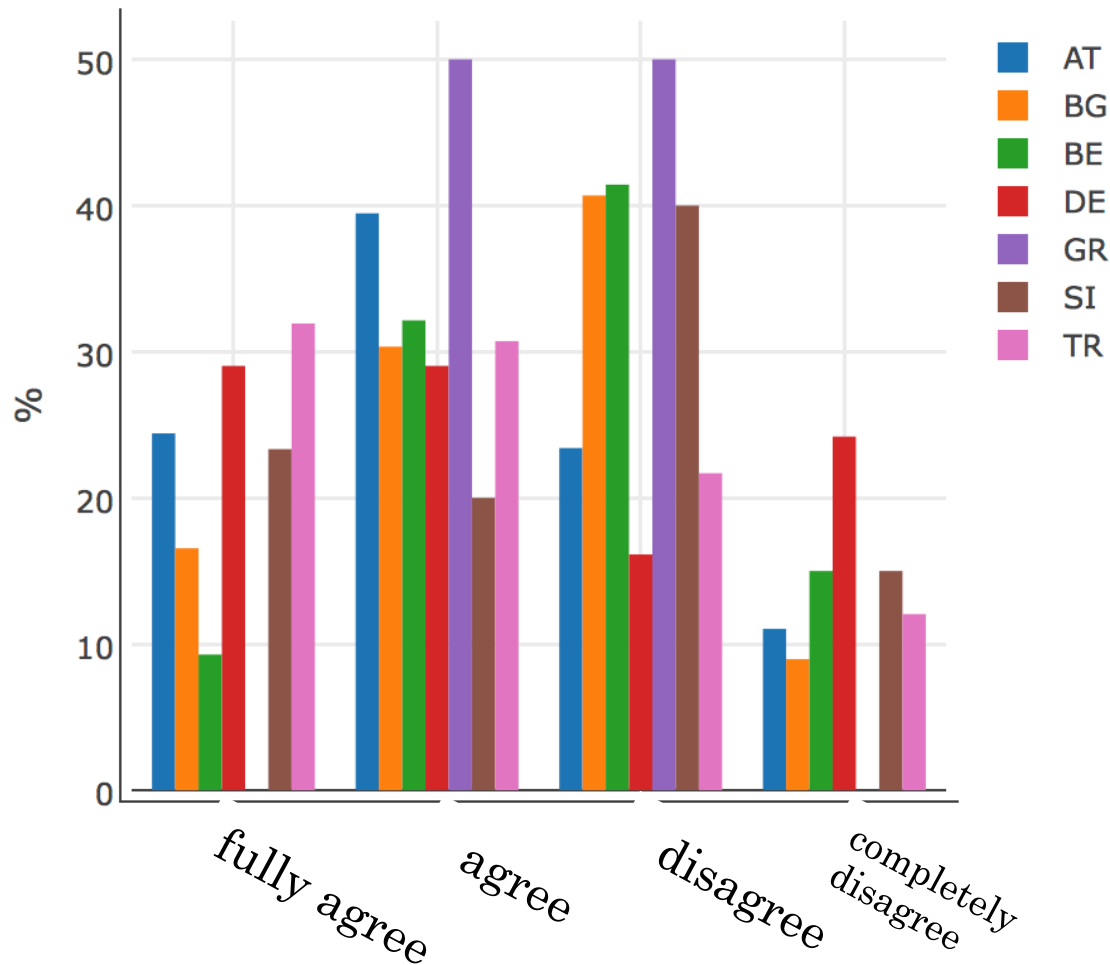

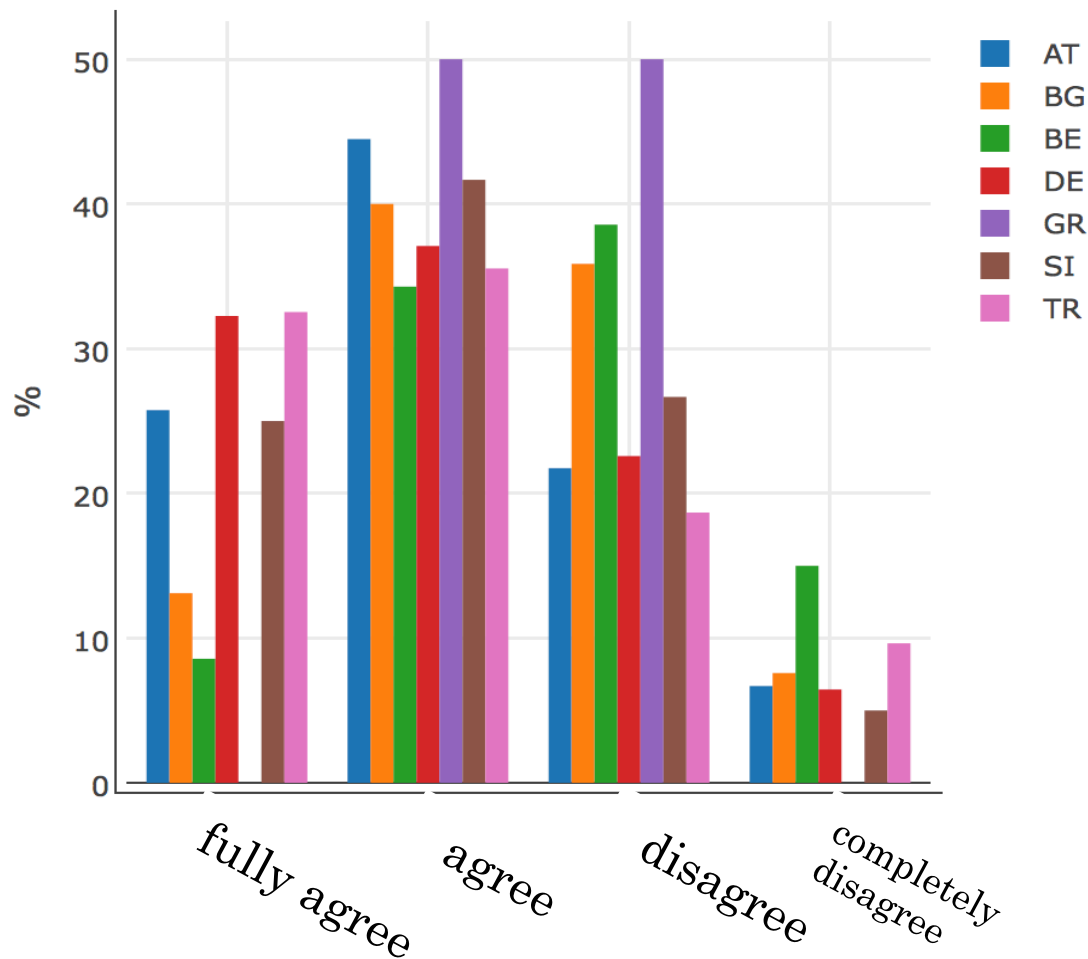

HOW DO I HANDLE PASSWORDS IN A SECURE WAY?

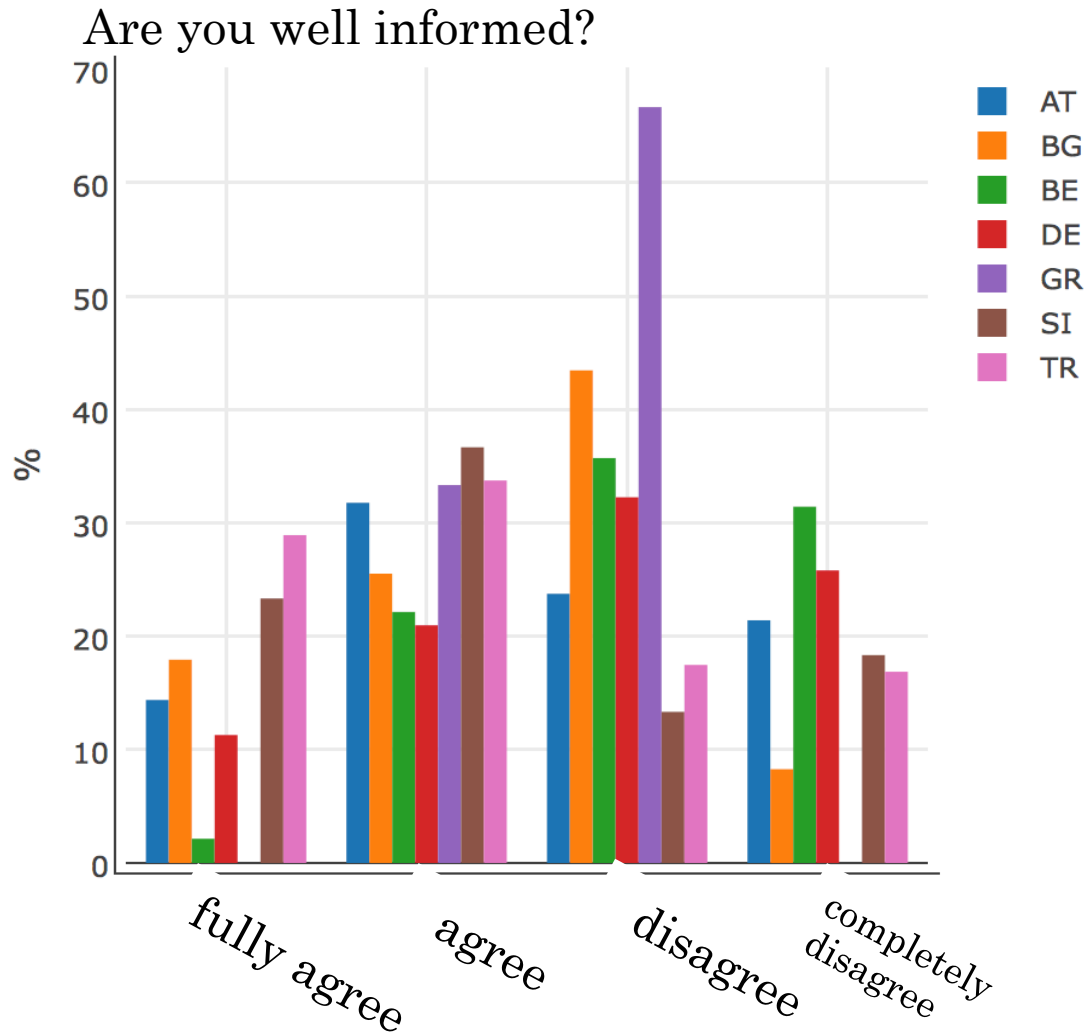

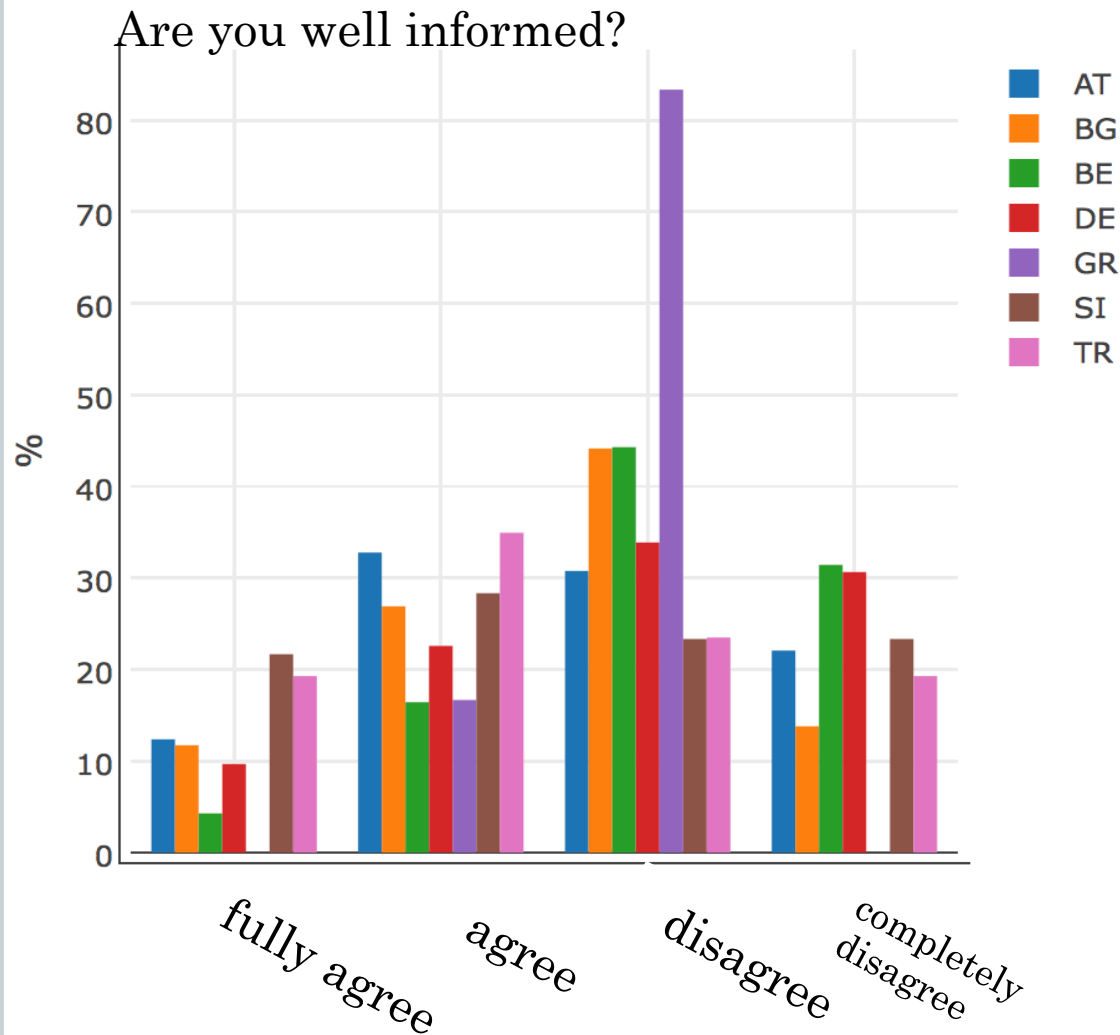
HOW DO I SET SECURITY SETTINGS IN SOCIAL MEDIA (E.G. FACEBOOK)?

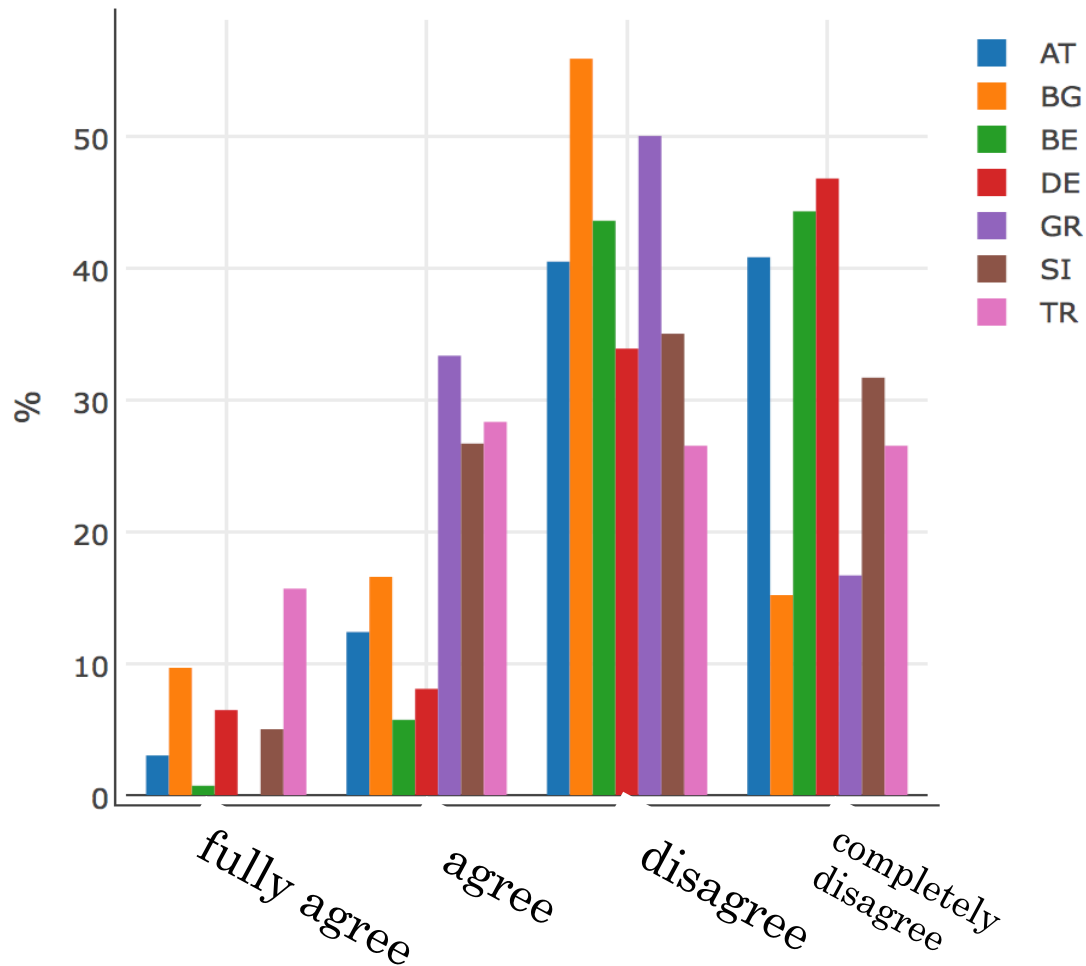

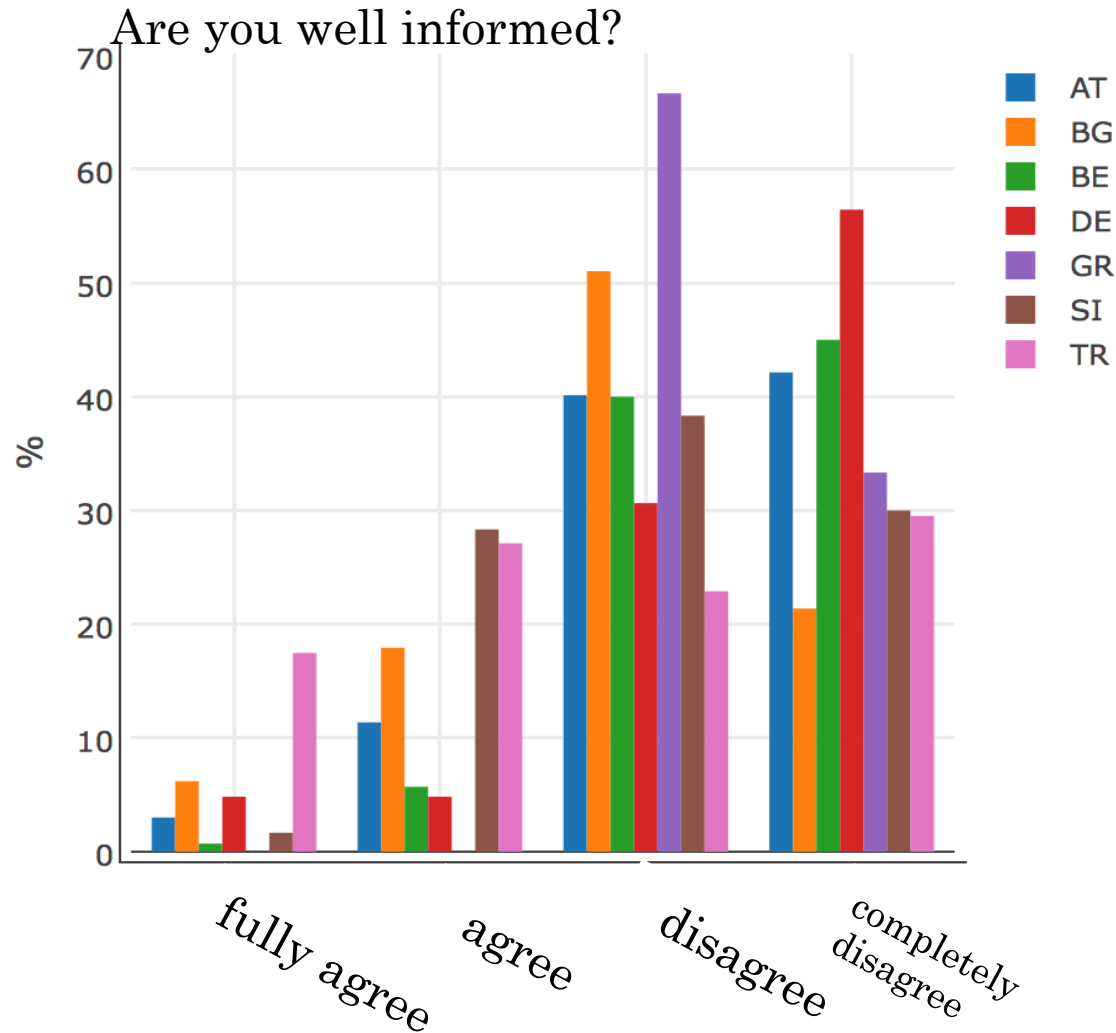

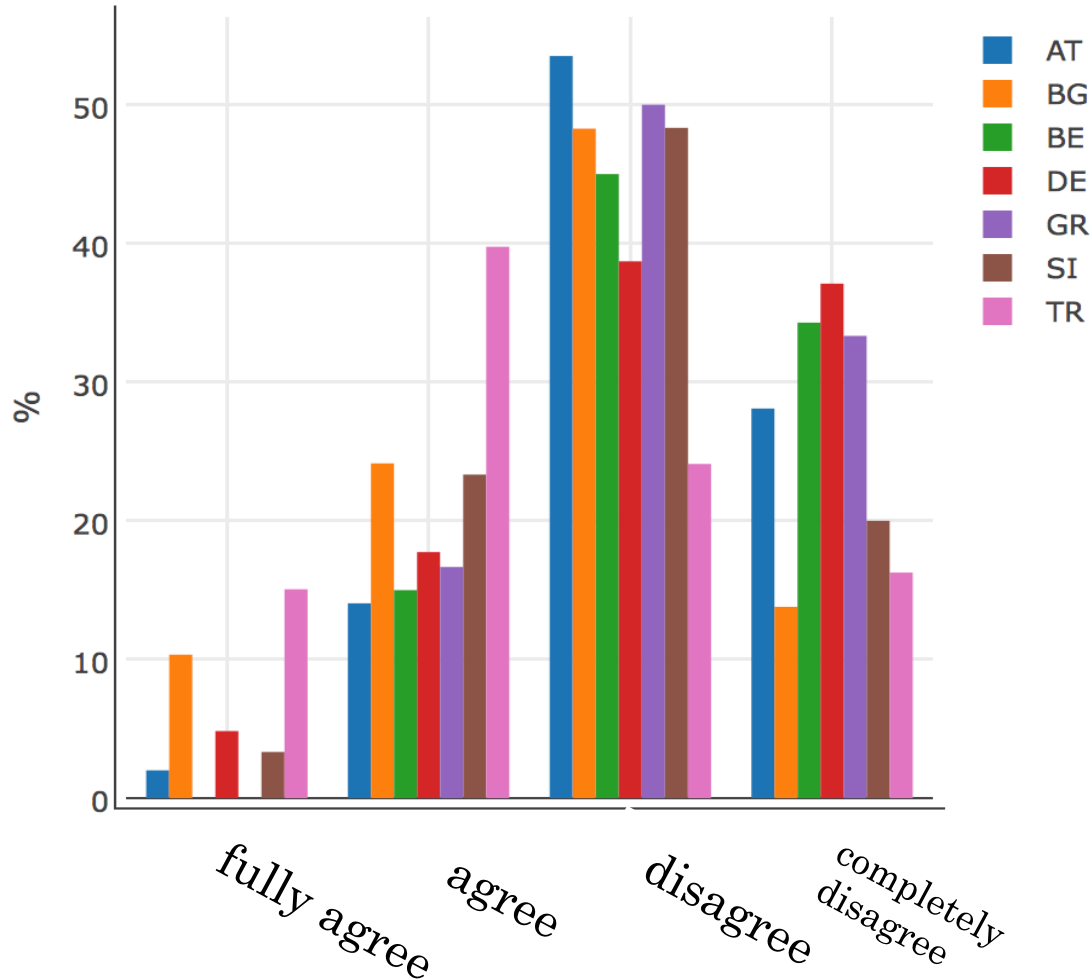

CONCLUSIONS

- **Most of the affected children are between 15-18 years old**
- **The most important media are smartphone and PC**
- **Most concerns people have when it comes to missuse of their data by criminals or companies.**

CONCLUSIONS

- **People have little information about wherefore companies use their personal information. → 67 % expressed information needs in this topic.**

CONCLUSIONS

- **Other highlight questions:**
 - Wherefore private individuals use my and my child's personal data?
 - How companies ensure the security of my and my child's personal data?
 - How I can remove personal online data?
 - In which countries companies transfer my and my child's personal data?

CONCLUSIONS

- There are no strong differences between countries.
- There is a slight tendency, the more well-informed people have more concerns.
- There is a slight tendency, that younger children prefer using a tablet.
